## FEE SCHEDULE—January 1, 2020

### Penalty Fee

All permits that require a fee are to be charged a penalty if the permit was not purchased before work was started. The penalty fee is 3 times the amount of the permit. For example: If a home building permit was needed, the permit fee would be \$400.00. The penalty would be 3 x \$400.00 or \$1,200.00 plus the \$400.00 for the original permit. So the total owed for the building permit is \$1,600.00.

**Non-Sufficient Funds Fee (NSF)** \$20.00 payment for each check and occurrence, when withdrawal is not honored of funds.

**Tax/Escrow Refunds** Refunds under \$2.00 will not be refunded.
